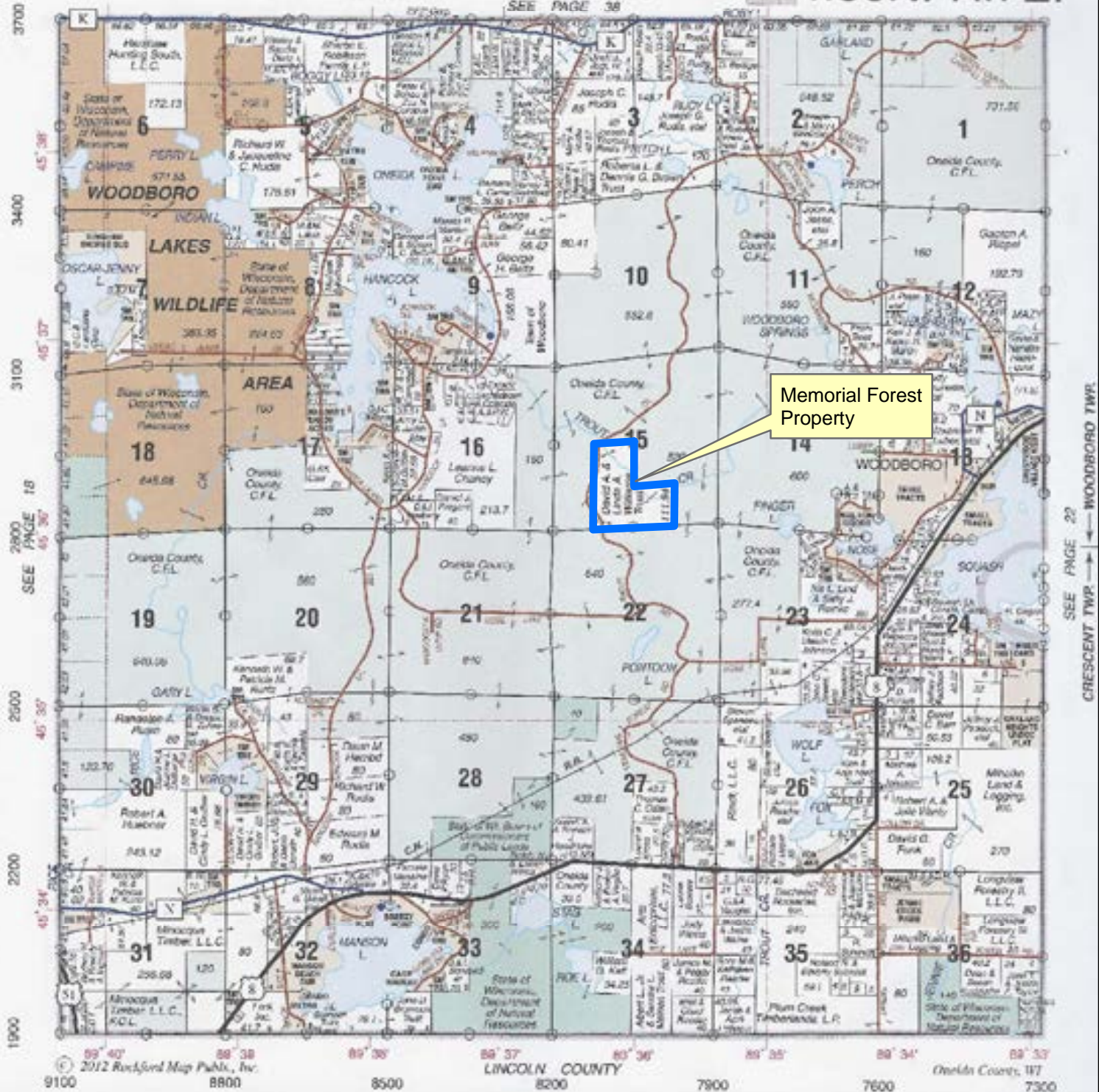

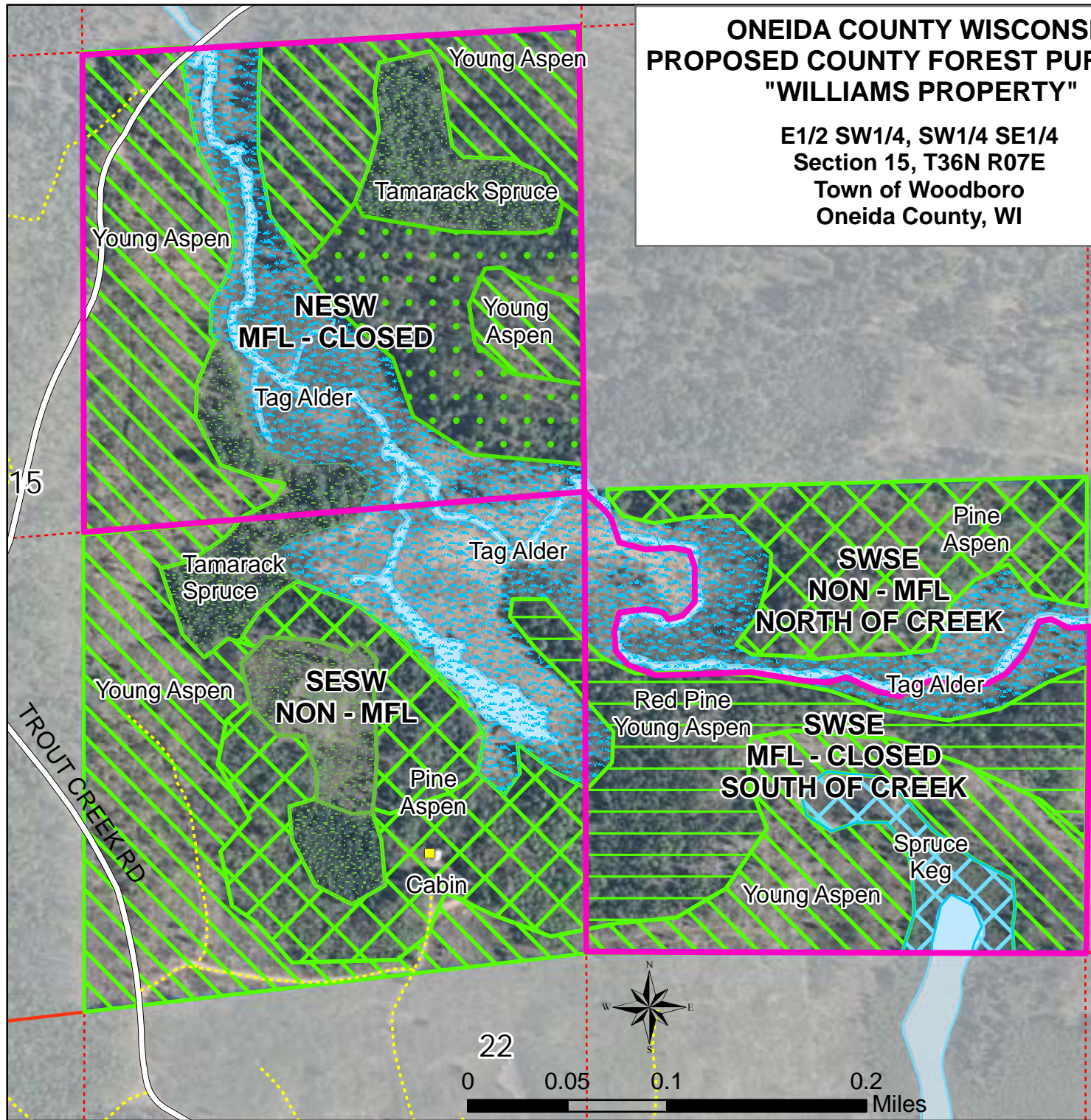

Hanson 80 East Property

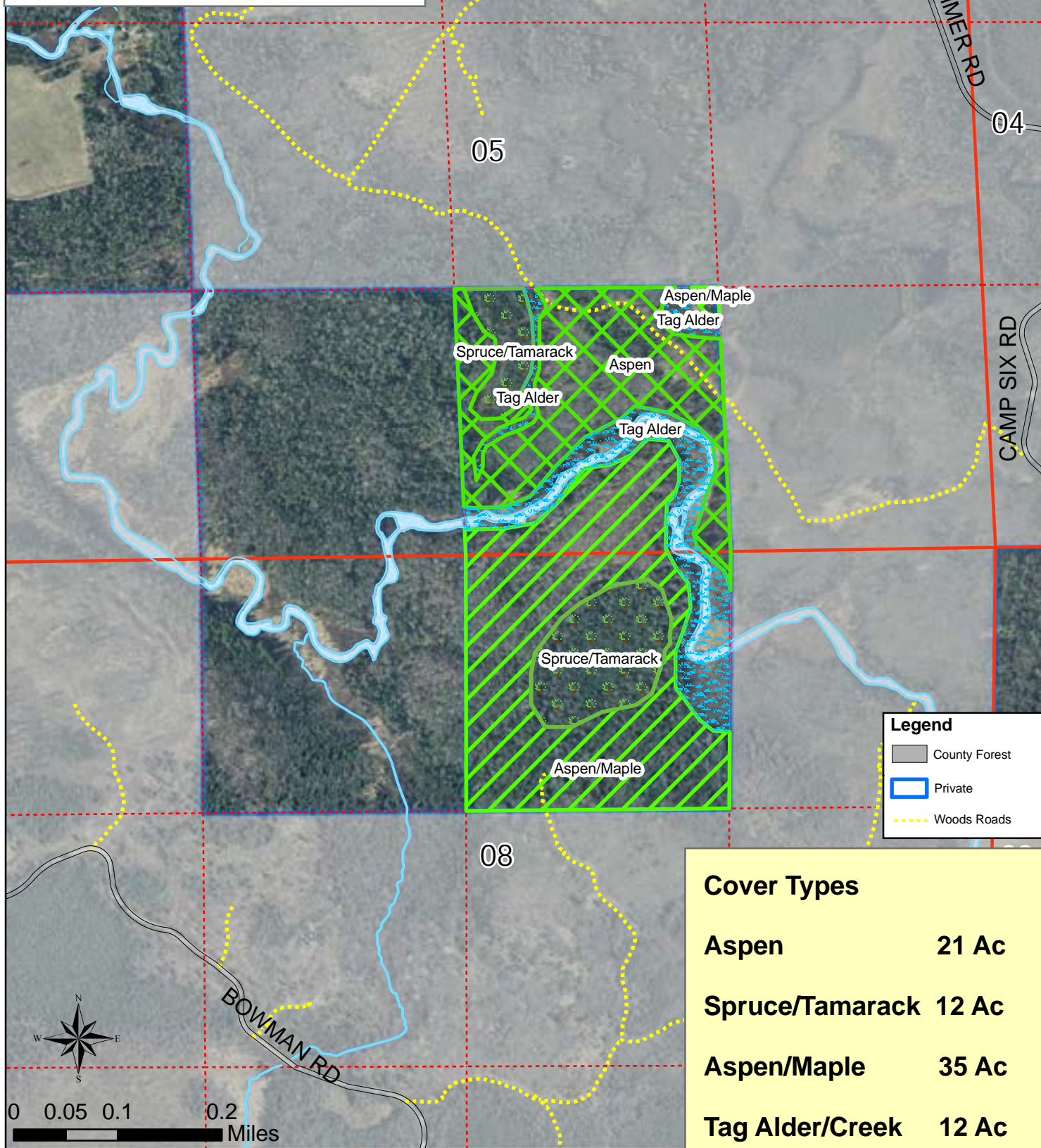

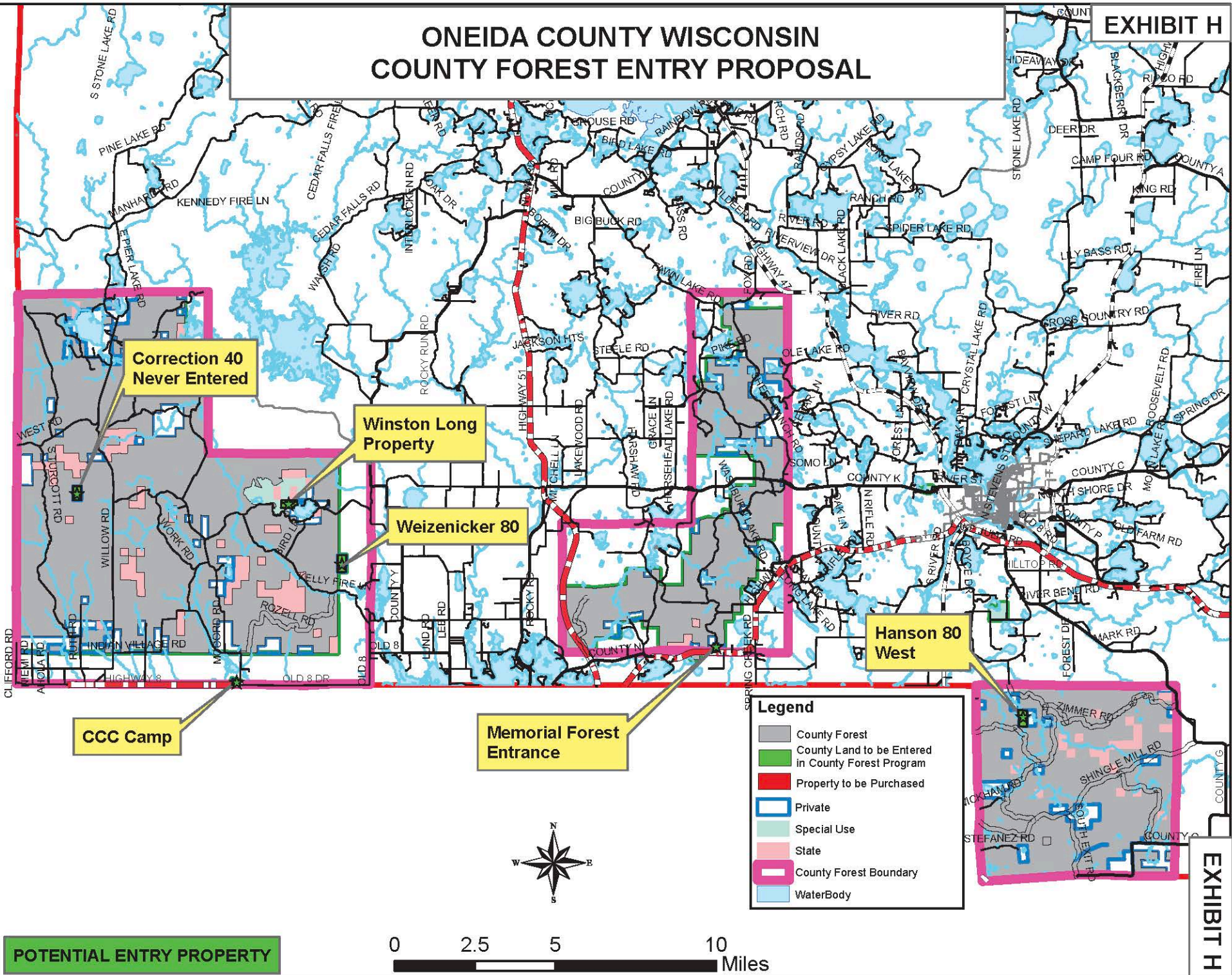
