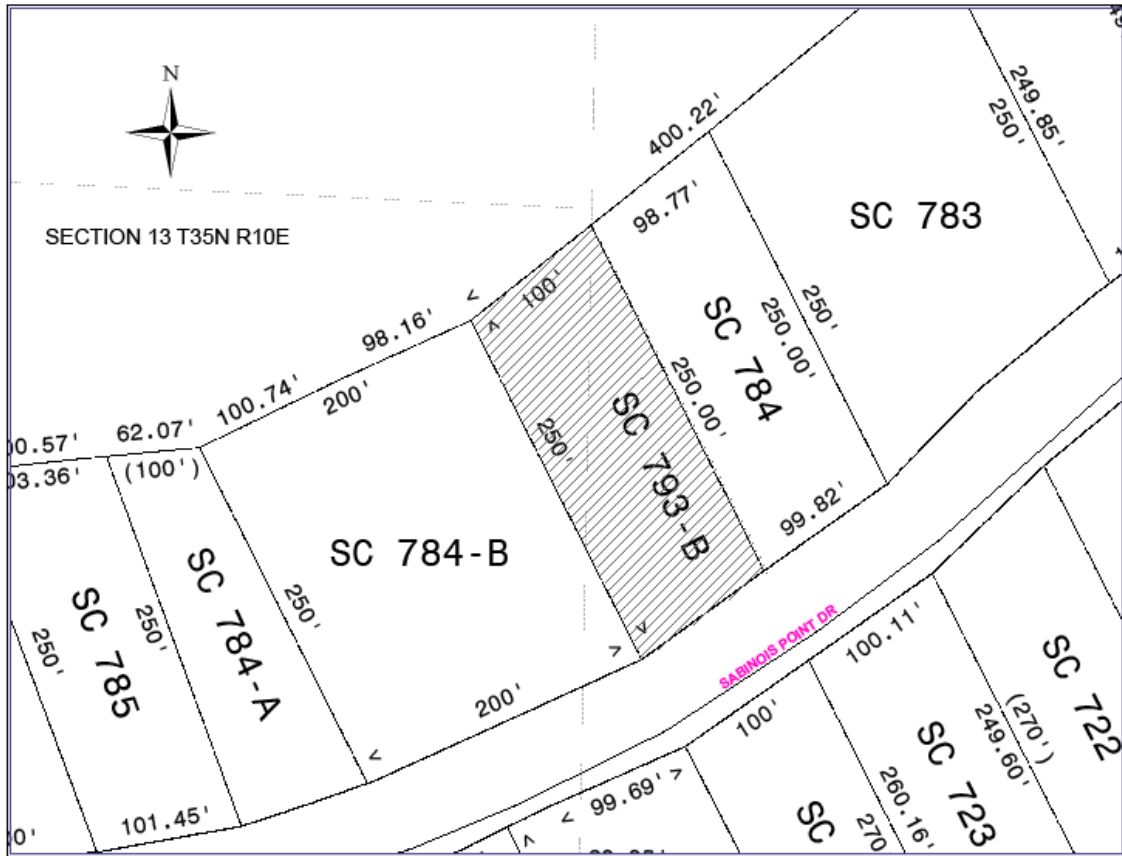

81 line of Lot 11 of said Plat, Northernly on the same degree; then East 100 feet on a line
82 parallel with the North line of said road; thence southerly 250 feet to a point where a
83 northernly prolongation, on the same degree of the East line of Lot 10 intersects the north
84 line of said road; thence westerly on the North line of said road to a point where a
85 prolongation Northernly on the same degree of the East line of Lot 10 intersects the North line
86 of said road; thence on a direct line to the place of beginning.
