

RESOLUTION # 58-2017

Resolution offered by Land Records Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Oneida County retained a 100 foot strip of land on each side of the center line of existing roads crossing the NW 1/4 - SW 1/4 of Section 35, Township 39 North, Range 9 East, as recorded in Volume 58 of Deeds, Page 125, Document Number 118640, together with timber rights on said land, recorded in Register of Deeds on June 12, 1944; and

WHEREAS, a request has been made to Oneida County from the adjoining landowner listed in Exhibit A below requesting that a portion of said strip of land described above adjacent to Blackberry DR be conveyed to them as they are the present adjoining owner of the land, and he has paid the \$100.00 administrative fee to process this request; and,

WHEREAS, the Town of Sugar Camp has been notified of this request and the Land Records Committee recommends that the parcel described in Exhibit A be conveyed to the adjoining landowner, provided the Town does not have any objection to said conveyance.

NOW, THEREFORE, BE IT RESOLVED, that the Oneida County Board of Supervisors hereby approves conveying the parcel described in Exhibit A below to the adjoining landowner as listed in Exhibit A, provided that the Town of Sugar Camp has no objection to such conveyance, and authorizes the County Clerk, upon receipt of the \$30 deed recording fees, to issue a quit claim deed conveying any interest the County has in the description described in Exhibit A.



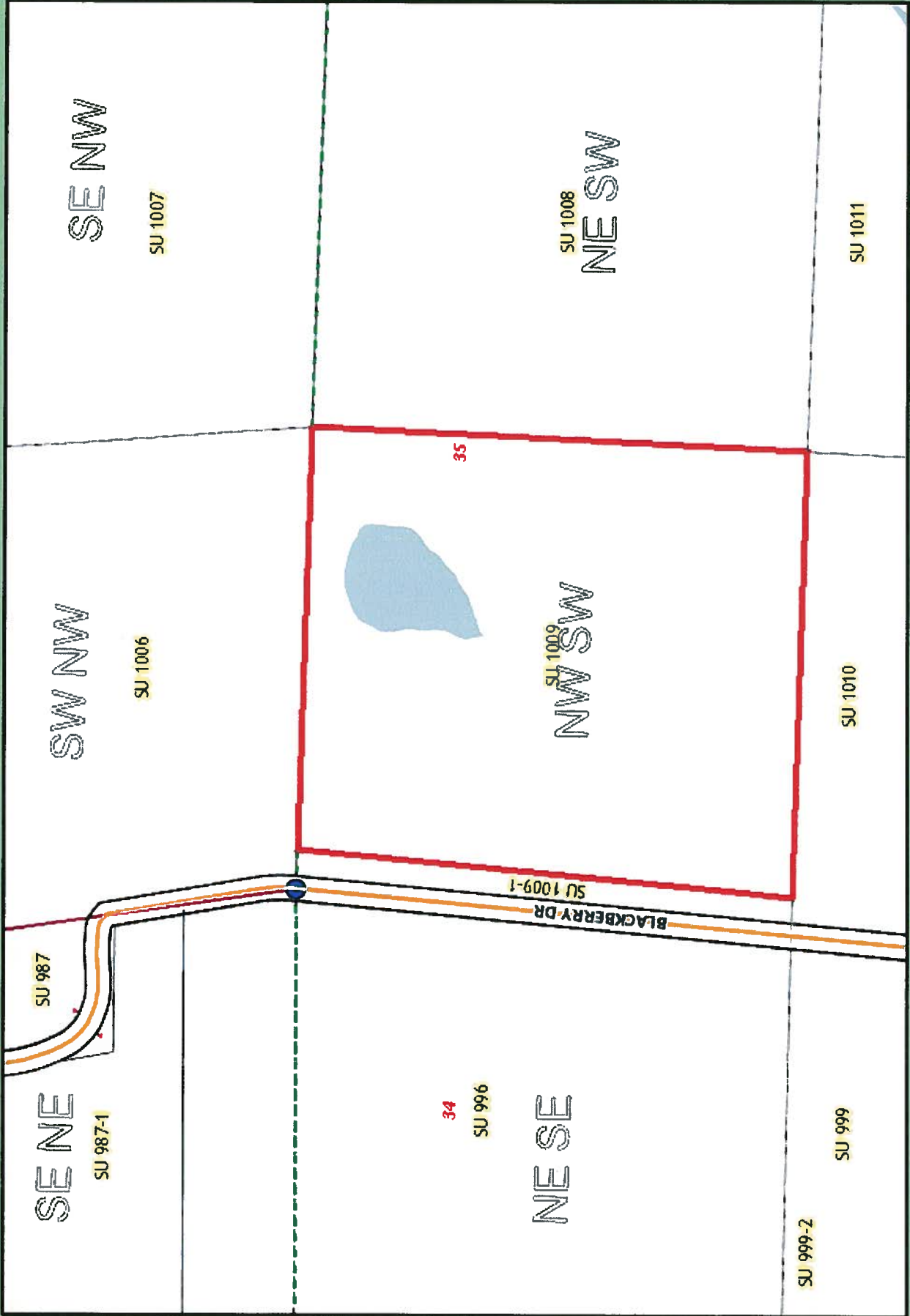
Exhibit A
