

## **Campground Use Regulations**

The following is a summary of regulations regarding the use of this campground. To see the complete list of regulations refer to Ch. 14.18 of the General Code of Oneida County or see our website at: [www.co.oneida.wi.gov](http://www.co.oneida.wi.gov).

Campground opens May 22 and closes on December 2.

FEES: \$15.00/night for each site.

Checkout time is 2:00 pm on the last day of the registered period.

Maximum length of stay is 14 nights in a row.

Quiet hours are from 10:00 pm to 7:00 am. Motorized generators and chainsaws may not be used during quiet hours.

Only registered campers are allowed in the campground between 10:00 pm and 7:00 am.

You must be at least 18 years of age to register a site.

No more than six people may occupy a single site.

All camping parties must set up a camping unit, (a recreational camping trailer, pop-up camping trailer, motor home, truck camper, or tent) in a useable condition for the entire period of registered occupancy. Sleeping in cars or on the ground in the open is not permitted.

A maximum of two camping units allowed per site with only one being a camping trailer, pop-up trailer, truck camper or motor home.

The site designated for the physically disabled may only be registered by a camping party with at least one member who holds a valid, state issued identification card indicating the card holder is physically disabled, unless that site is the last unoccupied site at which time anyone may register that site.

No picnicking in camp sites except by registered campers.

All refuse and recyclables must be disposed of in the trash receptacle and recycling receptacles provided.

Fires must be confined to the fire rings or grills and may not be left unattended at any time.

Registered campers may collect dead and down woody material within the campground boundary for use as firewood during their registered camp stay. Firewood may not be removed from the campground at any time.

No more than two pets (cats and/or dogs) allowed per camping party.

Pets must be on a leash not exceeding eight feet in length and must be under the owner's control at all times. Pets creating a nuisance may be cause for eviction of the owner and pet from the campground.

All pet waste must be cleaned up and disposed of in provided trash receptacle.

The use of fireworks is prohibited in the campground.

Within the campground boundary, firearms must be unloaded and in a carrying case at all times. Bows must be unstrung or in a carrying case at all times.

No hunting or trapping is allowed within campground boundaries.

Speed limit is 10 mph on the campground road.

ATV/UTV use is limited to the graveled portions of the campsites, the signed ATV/UTV trail and the graveled campground road except where posted closed to ATV/UTV's.

Any person may be evicted from the campground for violation of any State Law, Federal Law, Oneida County Ordinance or Campground Regulation.
