Hintz reported that while in closed session two motions were made and passed.

Hintz reported that the first motion was:

Sorensen/Liebert amend the motion to state we find the hearing officer's decision is arbitrary (meaning unrestrained and autocratic in the use of authority), oppressive (meaning unjustly inflicting hardship and constraint, especially on a subordinate) and unreasonable (meaning beyond the limits of acceptability or fairness) based upon the following examples but not limited to:

- 1) Two job performance evaluations show Pete is performed at or above standards
- 2) The Administration did not prove that any of the Lincoln County Dialog was done on County Time
- 3) Independent Hearing Officer held the hearing and allowed the focus of discussion to be on matters unrelated to Oneida County

Hartman read the second motion which reads:

Motion by Holewinski/Sorensen to reinstate "grievant" in a co-assistant director position with duties to be determined by the department head and committee of jurisdiction with the wage rate and benefits at time of termination and back pay under the rules with no consideration of the mitigation of damages from the day he was terminated until the day he comes back.
