Angela Swenson read a letter of support for the Human Service Center and shared a personal experience. Keith Hazelton Finance Director of the Human Service Center spoke. Ryan Schuppler spoke in support of the Human Service Center. Trinice Price of Rhinelander spoke in support of the Human Service Center. Maggie Peterson spoke against Resolution # 85 – 2023. Tim Johnson of the Oneida County Sheriff's Office spoke in favor of Resolution # 85 – 2023. Terry Loduha employee of the Human Service Center. Pearl Fessenden of Rhinelander spoke. Tyler Young of the Oneida County Sheriff's Office spoke. Chelsea Payant Corp Counsel of Forest County spoke in favor of dissolving the contract with Human Service Center. WHEREAS, Oneida County retained a 100 foot strip of land on each side of the center line of existing roads crossing the Government Lot 1 of Section 23, Township 37 North, Range 7 East, as recorded in the Register of Deeds, Volume 64 of Deeds on Page 150, Document # 106417, recorded on December 21st, 1939; and,

WHEREAS, a request has been made to Oneida County from the adjoining landowner listed in Exhibit A requesting that a portion of said strip of land described above adjacent to Sheep Ranch Road be conveyed to them as they are the present adjoining owners of the land, and they have paid the \$250.00 administrative fee to process this request; and,

WHEREAS, the Town of Cassian has been notified of this request and the Land Records Committee recommends that the parcel described in Exhibit A be conveyed to the adjoining landowner, provided the Town of Cassian does not have any objection to said conveyance; and,

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, the Oneida County Public Works Committee and the Highway Department seek to purchase one (1) Skid Steer; and

WHEREAS, the Highway Department has an account designated for the purchase of "Machinery" with funds available for 2023; and

WHEREAS, Oneida County Code sec. 3.09(2) requires County Board approval of purchases over \$100,000; an WHEREAS, the Highway Department and Public Works Committee believe that a new Skid Steer can be purchased for no more than One Hundred Eighteen Thousand. Six Hundred Ten dollars (\$118.610.00); and

WHEREAS, the Public Works Committee and the Highway Department have assessed their needs and determined that the purchase of a new Skid Steer is in the best interest of the department; and

<u>Resolution #85 – 2023:</u> Offered by the Supervisors of the Public Safety Committee and Social Services Committee to withdraw from the Tri-County Human Services Board.

Resolution to Withdrawal from Tri-County Human Services Board.

Resolution approved for presentation to the Oneida County Board by the Supervisors of the Public Safety Committee and Social Services Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Oneida County has been part of the Tri-County Human Services Board since November 13, 1984 by Oneida County Resolution 110-84.

WHEREAS, Oneida County signed the Joint County Human Services Agreement on December 21, 1984.

WHEREAS, F (9) of the Joint County Human Services Agreement - Withdrawal from the Tri-County Human Services Board: If any establishing county chooses to withdraw from the tri-county Human Services Board, it shall not withdraw prior to December 31st of the calendar/fiscal year. Further, it shall notify the Human Services Board and the other two counties by July 1st of the year preceding withdrawal, thus providing at least six (6) months advance notice.

WHEREAS, A group of County, Tribal and Elected officials from Forest, Oneida and Vilas Counties have met on several occasions and recommends a withdrawal from the current Human Service Agreement and to explore a change of structure in the Tri-County region, and,

THEREFORE, BE IT RESOLVED, that Oneida County is hereby giving notice to withdraw from the current Tri-County Joint County Human Services Agreement indicated above, as of December 31, 2024 to the Human Service Center Board and to Forest and Vilas Counties. Notification of this withdraw will also be provided to the State Department of Health Services and Department of Children and Families.

BE IT FURTHER RESOLVED, that the Director of Oneida County Social Services, the Oneida County Sheriff, and the Oneida County Corporation Counsel will convene meetings with their counterparts in both Forest and Vilas Counties, including Forest and Oneida County Tribal Nations representation, to discuss the structure of Human Services in the Tri-County region and to bring a recommendation to the Oneida County Board of Supervisors no later than April 30, 2024 March 31, 2024.

Discussion: Oneida County Sheriff Grady Hartman spoke stating that the decision today will determine how these services will be implemented in the future. Hartman noted that currently these services are provided through the Human Service Center. Hartman reported that our current system is antiquated, currently 64 of the 72 counties are providing these services in-house through Social Services. Hartman clarified that the Human Service Center is the vendor to provide these services. Hartman stated that all three of the counties are standing in solidarity that the services are not being provided in the manner that they should be. Hartman explained that they have tried to make changes in the past to meet in the middle and find a common ground without any resolution. Hartman stated that this Resolution is to end the contract and provide these services in a different manor. Hartman stated that there is a plan in place and Oneida County will need those employees. Hartman stated that the County Board will need to decide. Hartman noted that the three counties are in support of this Resolution. Oneida County Social Services Director Mary Rideout spoke regarding a packet that was emailed and also manually distributed, she noted that it is also on the Social Services website. Rideout explained the structure of Social Services throughout the state. Rideout stated that the discussion is restructuring and not eliminating services. Rideout stated that these services will still be provided, just done better with a different structure. Rideout reported that the agreement is old. Rideout stated that there is a misconception that the Human Service Center is a private organization, Rideout stated that this is actually in place by the three counties direction. Rideout stated that the Human Service Center is funded with Oneida, Vilas and Forest County dollars. Rideout explained the reasons for her support of this Resolution. Vilas County Social Service Director Kathryn Gardner stated that a lot of counties have gone through this same process and there are statutory structures already in place. Oneida County Clerk Tracy Hartman read a letter from the Forest County Social Services Director Tracy Shumacher in favor of withdrawing from the three county contract with the Human Service Center. Hartman read a letter from the Forest County Board Chair in support of withdrawing from the contract with the Human Service Center. Hartman read a letter signed by the Vilas County Board Chair, First Chair and Second Chair in support of withdrawing from the Tri-County contract with the Human Service Center. Tamara Feest stated that there is a lack of communication to the Human Service Center Board. Feest noted that there should be a plan in place if this change is to be implemented. Schreier explained that the Resolution speaks for itself. Schreier reported that historically this goes back to November of last year discussing the contract with the Human Service Center. Schreier stated that the Human Service Center has also indicated that they wanted to rewrite the contract. Schreier noted that after discussions with the other three counties it was determined that all three shared all of the same concerns. Schreier stated that there is a great deal of dysfunction and this goes back about 13 to 15 years. Schreier noted that this Resolution sets something in motion. Schreier clarified that this is not ending anyones job or services. Schreier stated these are mandatory services and we are just looking at a different structure. Showalter questioned if there were any services that would be eliminated, Rideout stated no. Showalter asked if there were any

grants that would no longer be available, Rideout stated no. Rideout stated that we need to manage and plan. Cushing stated that he was on the Human Service Center Board and County Board and feels that this was orchestrated. Newman stated that her complaint was how this happened. Holewinski questioned a situation in which the Human Service Center would not let the Sheriff's Office speak in meetings at the Human Service Center meeting. Discussion ensued regarding that meeting. Schreier stated how do you discuss the issues if you cannot discuss the issues. Winkler spoke in support of this Resolution and stated this is just a change in structure.

<u>Motion/Second Winkler/Jensen</u> to amend Resolution # 85 – 2023 on lines 32 and 33 to strike April 30, 2024 and change to March 31, 2024.

<u>Discussion:</u> Rio stated that people are seeking out help and the phone-in screeners are not helping. Rio stated that he understands that the Human Service Center also does good things but what is happening now is not working. Holewinski explained that the current structure will continue through 2024 and services will not change. Holewinski stated that the service will still exist.

<u>Motion/Second: Cushing/Newman</u> to amend line 31 to add after "Nations Representation", <u>and the executive director of</u> the Human Service Center.

<u>Discussion:</u> Schreier stated that the Human Service Center does not play any part in formulating its composition or existence, it is created by the three counties. Schreier questioned why would we include the Human Service Center as the provider in this process. Schreier noted that we want to make the decisions. Jensen clarified that they can attend the meetings as it is a public meeting.

Resolution to make a market adjustment to the ITS Director position on the Exempt Wage Schedule.

Resolution approved for presentation to the Oneida County Board by the Supervisors of the Labor Relations Employee Services (LRES) Committee

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, during the performance evaluation of the ITS Director, a discussion regarding the correct placement of the ITS Director position on the Exempt Wage Schedule to put Oneida County into the best position possible when hiring the position in the future: and

WHEREAS, the Administration Committee Chair and County Board Chair instructed the ITS Director and Human Resources (HR) Director to work together to come up with a solution; and

WHEREAS, the ITS Director and HR Director researched both private and public sector wages and hierarchy of director positions for the ITS Director position; and

WHEREAS, a recommendation was made to the Administration Committee by the ITS Director and HR Director to move the ITS Director position from Grade Level R of the Exempt Wage Schedule to Grade Level S of the Exempt Wage Schedule; and

WHEREAS, the Administrative Committee approved and recommended that the ITS Director position be placed at Grade Level S of the Exempt Wage Schedule and forwarded to the LRES Committee for further review; and

WHEREAS, the LRES Committee reviewed the recommendation from the Administration Committee and agreed with the placement of the ITS Director position at Grade Level S of the Exempt Wage Schedule; and

WHEREAS, the LRES Committee does recommend to the Oneida County Board of Supervisors to place the ITS Director position at Grade Level S of the Exempt Wage Schedule

THEREFORE, **BE IT RESOLVED**, by the Oneida County Board of Supervisors which authorizes and directs the following changes are implemented for the ITS Director position:

- ITS Director position be placed at Grade Level S of the Exempt Wage Schedule; and
- Incumbent employee shall be placed at Grade Level S, Step 8, effective the first day of the payroll period

following County Board approval; and

BE IT FURTHER RESOLVED, by the Oneida County Board of Supervisors that funds to cover this change are coming from the current ITS Department 2023 budget.
