7. Financial Elder Abuse Presentation: Presenter Amanda Thome:

Ms. Amanda Thome from Morgan Stanley did a Financial Elder Abuse Presentation. This presentation explained What is Elder Financial Abuse, Who Does Elder Financial Abuse Affect, Red Flags Indicating Financial Exploitation, Warning Signs of Financial Abuse, What can Seniors do to Protect Themselves. After Ms. Thome's presentation, Ms. Mary Rideout went over the 2021 Financial Exploitation for Oneida County statistics. Informational only, no action taken.

8. Northwoods Transit Connections Update:

10. Staffing Update-Dementia Care Specialist:

Ms. Danielle Przybylski, Dementia Care Specialist started on April 11, 2022. She introduced herself to the committee. Informational only, no action taken.

11. Dementia Innovations Update:

Mr. Joel Gottsacker reported that they had a meeting in April. They will be beginning to work with Dispatch to train them to assist people with Dementia in a medical model rather than through law enforcement, though law enforcement would continue to be involved. The next meeting is May 10, 2022. The hope is to be up and running by January 2023. There is a need for additional education is needed for dispatch, EMS and the community. Informational only, no action taken.

12. Cycling without Age:

Normally the §85.21 Grant would be given to the Transit Commission to cover costs associated with delivering transportation to the elderly and disabled. Due to pandemic funding, the Transit Commission's costs have been covered entirely by Federal funds in 2020 and 2021. This resulted in the §85.21 grant being put into the trust account, which has a balance of over \$200,000. Mr. Joel Gottsacker presented the Cycling without Age Program, which provides the opportunity for older adults who can no longer ride a bike a ride in a "trishaw" – a three-wheeled electric bike like a reverse rickshaw. This would mainly be used to get people who are in assisted livings/nursing homes etc. out and on a ride but not intended for a taxi service. The bicycles cost approximately \$10,000-\$15,000 per bike. The pilot of the bike would be a volunteer (with training) possibly through the RSVP Program. Would like to get a sponsor who would organize the rides, etc. and we would provide the bikes and the volunteers. Mr. Gottsacker is meeting with different organizations. Will bring back to the committee as the process progresses. Informational

only, no action taken.

13. Citizen member per diem – update:

Ms. Mary Rideout explained that this is still being finalized. There are other committees that have longer meetings and we would like to include all the information so this can be a complete product. Will get the final language and present in May. Informational only, no action taken.
