Proceedings of the Oneida County Board of Canvass held in the County Clerk's Office, Oneida County Courthouse, First Floor, on Friday, February 24, 2023 at 9:00 a.m. and Monday, February 27, 2023 at 12:00 p.m. The purpose is to canvass the Spring Primary held February 21, 2023.

Meeting notices were posted and media was notified by Tracy Hartman, County Clerk per Wis Stats.

## **Meeting/Canvass was called to order on Friday, February 24, 2023 by Cindy Skinner at 9:00 a.m.**

**Present:** Tracy Hartman, County Clerk; Cindy Skinner, Town of Pine Lake Clerk; Heidi Nehls, Chief Deputy Clerk.

Poll lists with supplemental lists, absentee ballot logs, tally sheets, tapes, and Inspector's Statements will be reviewed. Voter/ballot numbers to be checked for accuracy and compared to election night report. Forms to be checked for signatures and correct completion. Notations will be made below and municipal clerks will be contacted. The Tabular Statement of Votes Cast will be filled in after each municipality is reviewed. Upon completion of the reviews, the election night results will be reconciled for any errors and the Summary Statement of the Board of Canvassers along with the Certification will be completed and signed by the board and will be made a part of these minutes. Entries will be made into WisVote and the printed Summary Statement and Certification will be signed and mailed to the Wisconsin Elections Commission.

Optical Scan portion of Inspectors Statement not filled in. No Tally Sheet for write-in. Serial number from bag not recorded.

**City of Rhinelander – (Ward 1 – 3) – Voters – 124/ Ballots Cast – 126**

Two more ballots than voters. Looks that wrong ballots were given, this offsets Wards 9 & 12 with two less voters. Correct number on Voter Statistic Section should have been listed as 126. Serial number from the bag not recorded. Certification page and Absentee Ballot Log not submitted.

Serial number from bag not recorded. Certification page and Absentee Ballot Log not submitted.
