Proceedings of the Oneida County Board of Canvass held in the County Clerk's Office, Oneida County Courthouse, First Floor, on Tuesday, April 14, 2020 at 12:00 p.m., and on Wednesday April 15, 2020 at 8:30 a.m. The purpose is to canvass the April Spring Election and Presidential Preference Primary held April 7, 2020.

Meeting Notice was posted April 13, 2020, at 12:00 p.m. on the Courthouse Bulletin Board by Tracy Hartman, County Clerk per Wis Stats. Media notified April 13, 2020 at 12:00 p.m., via mail/fax/email.

Meeting/Canvass was called to order on Tuesday, April 14, 2020 by Cindy Skinner at 12:00 p.m.
