# Non-Partisan Spring Election April 2, 2019

Proceedings of the Oneida County Board of Canvass held in the County Clerk's Office, Election Conference Room, Oneida County Courthouse, First Floor, on Thursday, April 4, 2019 at 9:00 a.m., and on Friday April 5, 2019 at 9:00 a.m. The purpose is to canvass the April Spring Election held April 2, 2019.

Meeting Notice was posted April 3, 2019, at 7:30 a.m. on the Courthouse Bulletin Board by Tracy Hartman, County Clerk per Wis Stats. Media notified April 3, 2019 at 8:00 a.m., via mail/fax/email.

Meeting/Canvass was called to order on Thursday, April 4, 2019 by Cindy Skinner at 9:00 a.m.

Present: Heidi Nehls, Chief Deputy Clerk; Cindy Skinner, Town of Pine Lake Clerk; and Tracy Hartman, County Clerk.

Poll lists with supplemental lists, absentee ballot logs, tally sheets, tapes, and Inspector's Statements will be reviewed. Voter/ballot numbers to be checked for accuracy and compared to election night report. Forms to be checked for signatures and correct completion. Notations will be made below and municipal clerks will be contacted. The Tabular Statement of Votes Cast will be filled in after each municipality is reviewed. Upon completion of the reviews, the election night results will be reconciled for any errors and the Summary Statement of the Board of Canvassers along with the Certification will be completed and signed by the board and will be made a part of these minutes. Entries will be made into WisVote and the printed Summary Statement and Certification will be signed and mailed to the Wisconsin Elections Commission. No Provisional Ballots were issued.

Tracy Hartman will take the minutes. Cindy Skinner and Heidi Nehls will review together each municipality and complete checklist.

## **Town of Cassian** – *Voters* – 267/ *Ballots Cast* – 267

Ballot security seal number missing from EL-104. Signature missing from Absentee Envelope. Poll book was missing some signatures of voters, there were signatures with no voter number assigned.

# **Town of Crescent (Wards 1, 2 & 3)** – *Voters- 449/ Ballots Cast – 449*

Voting machine unit number is missing. Chief Inspector signature missing.

## **Town of Enterprise** – *Voters* – 116/Ballots Cast – 116

Last voter number was not circled. Absentees were not listed in red.

## **Town of Hazelhurst** – *Voters* – 383/ Ballots Cast – 383

Missing information on Voter Statistic section of the Inspectors Statement. Edge ballots not in ballot bag, County Clerk sealed into separate ballot bag. Missing machine unit numbers on Inspectors Statement. Page 11 in Poll Book voter signed the wrong line. Page 66 a voter number was missing. Page 96 was missing a voter signature.

# Town of Lake Tomahawk (Wards 1 and 2) – Voters – 281/Ballots Cast – 281

Voter Statistic section of Inspectors Statement was missing most information. Last voter number not circled.

All reports signed and completed correctly.

# **Town of Lynne** – *Voters* – 40/ *Ballots Cast* – 40

Last voter number not circled in Poll Book. Poll Book page 9, missing a number by signature.

### **Town of Minocqua** – *Voters* – 1249/ *Ballots Cast* – 1249

Last voter number not circled. Voter Registrations did not list proof of residence. Rejected Absentee had time to be corrected based on postmark. Change of address are marked in Poll Book only, these need to be re-registered. Many voter numbers were crossed off and changed. Minocqua does not use 2 Poll Books, this is mandatory. Minocqua was unable to be reconciled on Thursday afternoon and will be looked at again on Friday.

Last voter number not circled. Original remade ballots not placed in ballot bag. Canvassers placed original ballot envelope and destroyed ballot envelope into a ballot bag and secured.

## **Town of Newbold (Wards 2, 3 and 4)** – Voters – 624/ Ballots Cast – 624

Last voter number not circled. Destroyed ballots not placed in ballot bag. Canvassers placed original ballot envelope and destroyed ballot envelope into a ballot bag and secured.

#### **Town of Nokomis** – *Voters* – 323/Ballots Cast – 323

Poll book page 12 missing signature, page 33 voter number listed by wrong voter. Red ink used for everything, red should be only used for Absentee.

#### **Town of Pelican** – *Voters* – 580/ *Ballots Cast* – 580

Not all election workers signed the EL-104. Poll Book error on page 97, #317 issued twice. Pelican was unable to be reconciled on Thursday afternoon and will be looked at again on Friday.

#### **Town of Piehl** – *Voters* – 25/ *Ballots Cast* – 25

Last voter number not circled and wrong page listed.

## **Town of Pelican** – *Voters* – 580/ *Ballots Cast* – 580 - *Continued from Thursday*

Not all election workers signed the EL-104. Poll Book error on page 97, #317 issued twice (this made reconciling difficult and the reason it took two days).

#### **Town of Pine Lake** – *Voters* – 575/ *Ballots Cast* – 575

All reports signed and completed correctly.

## **Town of Schoepke** – *Voters* – 145/ Ballots Cast – 145

Post Election portion of Inspectors Statement not initialed.

**Town of Stella** – *Voters* – 124/Ballots Cast – 124

Tally sheets were missing.

**Town of Sugar Camp** – *Voters* – 441/ Ballots Cast – 441

Edge tape was missing, could not determine if machine was set up. Tamper Evident Seal for the Edge was also not listed.

**Town of Three Lakes** – *Voters* – 804/ *Ballots Cast* – 804

Edge tape missing. Inspectors Statement was incomplete; Voter Statistic section and Tamper Evident portion was missing information. Poll Book listed signature with no voter number assigned.

**Town of Woodboro** – *Voters* – 212/ *Ballots Cast* – 212

Last voter number not circled. Scattering was not reported on election night but there were multiple write-ins. Inspectors Statement not complete.

**Town of Woodruff** – *Voters* – 474/ *Ballots Cast* – 474

Inspectors Statement had errors; Tamper Evident numbers were incorrect and EDR numbers were incorrect. Spoiled ballot envelope not placed in ballot bag. Canvassers placed spoiled ballot envelope into a ballot bag and secured. Poll Book page 103 was missing a signature.

Change of address are marked in Poll Book only, these need to be re-registered. Many voter numbers were crossed off and changed. Minocqua does not use 2 Poll Books, this is mandatory. There were a number of voter's without signatures or voter numbers assigned to them. This made reconciling difficult.
