Proceedings of the Oneida County Board of Canvass held in the County Clerk's Office, Oneida County Courthouse, First Floor, on Thursday, April 8, 2021 at 9:00 a.m. The purpose is to canvass the April Spring Election held April 6, 2021.

Meeting Notice was posted April 7, 2021, at 1:00 a.m. on the Courthouse Bulletin Board by Tracy Hartman, County Clerk per Wis Stats. Media notified April 7, 2021 at 1:00 a.m., via mail/fax/email.

Meeting/Canvass was called to order on Thursday, April 8, 2021 by Tracy Hartman at 9:00 a.m.

Present: Cindy Skinner, Town of Pine Lake Clerk; Carla Fletcher, Town of Crescent Chief Election Inspector; Debra Neuman, Deputy Clerk; Heidi Nehls, Chief Deputy Clerk; Tracy Hartman, County Clerk.

Poll lists with supplemental lists, absentee ballot logs, tally sheets, tapes, and Inspector's Statements will be reviewed. Voter/ballot numbers to be checked for accuracy and compared to election night report. Forms to be checked for signatures and correct completion.
