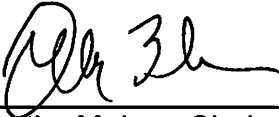
Chairman Melms announced that interviews had been conducted for Patrol Sergeant.

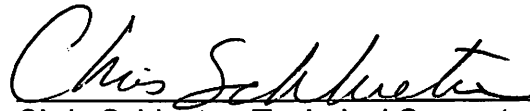
