**Election of Officers:**


**Motion/Second Blicharz/Carriere** that all officers remain the same. All "Aye", motion carried.

**Motion/Second VanRaalte/Kelly** that nominations be closed and the officers be appointed by acclamation. All "Aye", motion carried.


