# Land Information Office Staffing Update.

Chiamulera introduced the new GIS Specialist/Addressing Coordinator, Michael Fondow. Chiamulera gave an update on the current Land Information Office staffing. Chiamulera announced that Sara Jewell has filed her resignation as the Real Property Lister/Assessment Coordinator. Jewell will continue with the County as an LTE, to assist in the training process of the new RPL hire. The Real Property Lister/Assessment Coordinator position has been posted. The Land Information Aide position is still, and will remain, vacant until Chiamulera can assess further staffing needs and the status of the current medical leave is known.

#### Land Sales Update.

The Administration Committee approved the Treasurer to continue with the land sales process, with a court date set for August 17th. Chiamulera informed the committee of the changes to the tax delinquent land sales process due to Senate Bill 829, Act 216, which states that from the land sale, the County will be able to recover any taxes/fees, etc. imposed on the property, and profit above that will go to the former landowner. The land sales process was discussed.

# Land Information and Register of Deeds 2023 budget planning meeting.

Chiamulera inquired about whether the committee will hold a special meeting to go over the budgets for 2023. Franson explained that in the past the budget discussions took place in the scheduled August meeting and the department heads sent their drafted budgets to the committee two weeks prior, allowing time to review. This year the meeting will be on August 9th. Franson and Chiamulera will send out their budgets two weeks prior and if the committee members have any questions they can reach out.
