## 2023 Budget Review

Chiamulera updated the committee of the Land Information Office's budget review process. There was one change to the Land Information Office budget as it was approved by the Committee, which resulted from a typo in salary data. That issue was addressed and changed, and budget was approved by Administration Committee. Chiamulera presented Register of Deeds' budget review in Franson's absence. The Administration Committee increased ROD's projected revenue \$20,000, from initial \$180,000 to \$200,000; all else was approved as presented.

#### Discussion of tax parcel PL-458-100

Fugle presented an update to the PL-458-100 ongoing discussion. The interested parties are working together and are finalizing their agreement; they have requested postponement of final decision on sale, and another month to present their plan for the parcel.
