#### Update/Discussion of In Rem Parcel tax parcel RH-783, 825 N Stevens St, Rhinelander

History on RH-783, a tax delinquent parcel, was presented by Fugle. The Admin Committee forwarded the discussion on this parcel to the Land Records committee. This is the "Monster Mart" property. Owners are EURO-AMERICAN REALTY INVESTORS INC. There is interest by the City to move forward on this parcel.
