COVID -MASKING POLICY – COUNTY FACILITIES

The LRES Committee received and discussed information regarding the status of COVID cases in Oneida County. McMillion explained that the CDC and Oneida County Public Health are strongly recommending vaccinated and unvaccinated people wear masks when indoors due to the increase in cases.

The Committee agreed that all facilities should be posted with a recommendation to wear masks indoors, with department heads having flexibility in administering the recommendation with staff and the public in their offices. The committee also agreed that this was not a mandate.

Motion by Paszak, second by Holewinski to have all county facilities posted with signage asking all people entering to wear masks, allowing department heads the flexibility in how they administer this recommendation with their staff and public in their offices. All Committee members present voting ‘Aye’. Motion carried.
