SHERIFF'S OFFICE

Jail Revenue-Ashland County

Chief Deputy Hess gave an update that since January 2022, the Oneida County Jail is housing female inmates from Ashland County, and this will continue through June 2022. Hess reported this has brought in approximately \$9,700.00, and there are approximately 8-10 inmates per day. There was discussion about who transports the inmates, if this inhibits the availability of space, the rates, if female jailers needed to be on staff, and where the inmates were housed.

No action needed, as this was just an update.

Request Continuing Appropriation for Firearms Expenses

Hess reported that it has been rough and expensive to get ammunition. Hess reported the Sheriff's Office has orders from 2-3 years after and finally receive one for 9mm, with two more coming in. Hess would like to switch this to a continuing appropriations account, as it is unknown when the supplies will actually arrive. Based on the order the Sheriff's Office has out there now, Hess would like to take \$10,000-\$15,000 from last year's budget and this year's budget to place into continuing appropriation account. Hess spoke with finance and they are okay with this, and going forward, this account will be budgeted as continuing appropriation. Discussion on what was given back, if things go back to normal this will go back to a regular line item, how the orders were paid, that the budget was not closed yet, how costs continue to rise, and availability is low, and the proper process for this to occur. Hess stated this will be a carryover account, whatever is left in 2021 will carry forward to 2022, 2022 to 2023, etc.

MOTION: To approve the Oneida County Sheriff's Office request to turn the line item of Firearms Expense into a new Continuing Appropriation account, carrying over \$15,000.00 from the 2021 budget and moving the amount from the 2022 line item budget to the new Continuing Appropriation account for Firearms Expenses, with the Chief Deputy to negotiate/work with the Finance Department on this process, and forward to County Board if necessary (Fried/Ives, PASSED)
