

MEETING OF THE ONEIDA COUNTY HIGHWAY TRAFFIC SAFETY COMMISSION

The following matters were taken up to wit:

1. Kirby called the meeting to order at 12:30 p.m. It was noted the meeting was properly posted and the media notified.
2. **Motion:** Olig/England to approve the agenda. All ayes.
3. **Motion:** Olig/England to approve the minutes of the previous meeting. Kirby abstained. Remaining all ayes.
4. Oneida County and State Crash History and Data for 2021 to date. Statewide fatalities at 536 as of yesterday compared to 531 at this same time for 2020. Statewide fatalities for all of 2020 were 594 compared to 550 in 2019. Oneida County had 503 crashes to date compared to 505 this same time last year. Two fatalities to date compared to five same time last year.
Since the last meeting, there has been one fatality in Oneida County at the intersection of USH 51 and CTH "D".
5. 2022 Budget items. Discussed purchases for next year. Will discuss further at next meeting.
6. Discussed WisDOT New County Profile Report. Information and reports can be found on the Community Maps portal. A brief description of Legislative Updates. England and Olig discussed if there was any talk of Deferred Prosecution for offences like 'Failure to Yield' and other similar offences. Have the accused take a class, like what Nicolet College offers. Once the offended successfully completes a safety class, they do not have to pay fine and they get their points back. England wanted to know if other agencies around the state do this. Olig said he did not know of any.
7. WisDOT Construction Updates. Baier updated the committee on the State construction projects. All 2021 Project have been completed. Projects for 2022 include:
 - Highway 32 east of Three Lakes large culvert replacement
 - Highway 8 east from Monico to the Forest county line will be a resurface
 - Highway 47 from Kildeer to Vilas county line resurface with culvert and beamguard replacement
 - Highway 45 from Highway 32 to Vilas county line resurface with culvert replacement
8. County Construction. Cooper reported that all 2021 projects are completed
